
The eligible companies/firms/contactors authorized and capable to conduct security services and enable to arrange above mentioned manpower, may bid on the terms & conditions and requirements mentioned in the tender document which can be purchased by the interested agencies from Directorate of Procurement PARC Room # 228 (2nd Floor) on any working day from (8:00 AM to 4:00 PM) Monday to Friday from **07-09-2023** on written request of the firm/company letter head/pad with firm registration certificate valid license holder and GST / NTN number along with pay order / bank draft amounting to **Rs.1500/-** (Non-Refundable) drawn in favor of PARC, Islamabad.

Bidders who may fulfill and abide by the prescribed terms & conditions contained in tender document may submit / send their technical and financial bids along with all attachments as per format in separate envelopes. The bids will be received on or before **22-09-2023** by 1100 a.m., and will open on the same day at 1130 a.m. in the presence of bidders or their representatives. No tender will be sold on date of opening of tenders.

Each bid should be accompanied with Rs.80, 000/- earnest money (Refundable) in shape of bank draft or pay order in favor of PARC. The conditional bids or the bids without earnest money or containing less earnest money shall not be entertained / accepted by the committee.

The payment of all taxes is the responsibility of the firms. PARC reserves the right to reject any or all bids proposals or may cancel the tender at any time prior to acceptance of a bid or proposal. However PARC shall upon request communicate to any company/firm or contractor who submitted a bid or proposal, the grounds for its rejection of bids / proposals, but is not required to justify those grounds. PARC may decrease or increase/change in number of manpower and terms and conditions as well.
